The written test paper shall consist of 50 questions of multiple choice types with single correct answer One Hours (01 Hours) duration. The answer will be in the form of A, B, C & D each question will carry 01 mark. The question paper will be only in English medium. The questions will be based on subject contents as per advertisement.
