1. You are hereby invited to submit sealed quotation comprising competitive rates for the supply of the following drugs.

02. BID PRICE

- The contract shall be issued as per lowest quoted rate. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- All duties, taxes and other levies payable by the vendor under the Contract shall be included in the total price. Bidders are requested to quote the rates as per Performa enclosed.
- The prices shall be quoted in Indian Rupees only.

d) Copy of valid drug license and WHO GMP certification must be submitted along with quotation. Authority letter of the manufacturer and drug list is required to be submitted.

03. Each bidder shall submit only one quotation.

04. VALIDITY OF QUOTATION

The rates quoted in the quotation shall remain valid for a period of 1 year from date of opening of bid mentioned here.

05. EVALUATION OF QUOTATION

The CSACS shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- Are properly signed; and
- Conform to the terms and conditions and specifications.
- Quotations would be evaluated for all the items separately
- Notwithstanding the above, the CSACS reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- The bidder whose bid is accepted will be notified for supply of ARV Drugs. The terms of the accepted offer shall be incorporated in the purchase order.

06. **EMD-** The bidder shall submit EMD amounting to Rs. 5000/- in Electronic / NEFT/RTGS mode in the SBI bank account no.65265418988 (IFSC: SBIN0050736) of "Chandigarh SACS Special Grants"

which will be refunded to the unsuccessful bidders immediate after opening of the bids. Bids without EMD shall be rejected straightway.

07. **Packing terms:** - Medicines should be well packed in hard card board containers, which should stand up to the toughest transport condition. Damaged cartoon or medicines will not be accepted.
08. **Delivery Terms:** - Medicines will be delivered to Store Officer, Chandigarh AIDS Control Society International Hostel, Sector 15-A, Chandigarh. Extension will be considered only in exceptional deserving cases on written request. Medicines will have to be delivered within 30 days from the date of issue of supply order.
09. **Medicines to be supplied by supplier should not have lived more than 1/3rd of their shelf life.**
10. You are requested to provide your offer latest by **2.00 P.M hrs. On 11/12/2023 preferably By Registered Post super scribing "QUOTATION FOR TAB. Atazanavir 300mg + Ritonavir 100mg" DUE ON 11/12/2023 on the envelope.**
11. The quotation can be dropped personally in quotation box lying at the Reception. **Quotations received through E-MAIL will not be considered.**
12. Quotations will be opened in the presence of the Bidders or their representative who choose to attend at 3.00 p.m on **11/12/2023** in the office of the CSACS, UT Chd. The representative of the firm who wish to witness the proceeding for Opening of quotations shall come with signed authorization and Identity proof.
13. The contractors/Agencies will be fully responsible for any damage to the incomplete work due to negligence or natural calamities.
14. No interest will be paid on the delayed payment. The payment will be released only after having satisfactory report from the concerned department/ section.
15. In case there happens to be any holiday on the date of opening of quotations, the same will be opened on the next working day at the same time. Other terms and conditions will remain the same.
16. **Quantity can be increased or decreased as per requirement.**
17. The supply should be as per the specifications mentioned in the supply order and will be accepted after inspection.
18. In case of delay of supply: - Liquidated damages will be charged @ 0.5% per week subject to maximum deduction of 10% of contract price.
19. If supplier's company is registered under small medium and micro enterprises act then it is mandatory to enclose the certificate along with quotation.
