Terms and Conditions

01. BID PRICE

- All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- The prices shall be quoted in Indian Rupees only.
- The rate of taxes to be charged (if any) shall be clearly mentioned.

02. Each bidder shall submit only one bid.

03. VALIDITY OF BID

Bid shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

04. EVALUATION OF QUOTATION

The CSACS shall evaluate and compare the bid determined to be substantially responsive i.e. which

- Are properly signed; and
- Conform to the terms and conditions and specifications.
- The quotations would be evaluated for all the items together.
- The vendor should have TIN/ Service tax registration number and the same should have been reflected on letter head.

05. AWARD OF CONTRACT

The CSACS will award the contract to the bidder whose bid has been determined to be substantially responsive and who has offered the lowest evaluated rates.

- c. Notwithstanding the above, the CSACS reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- d. The bidder whose bid is accepted will be notified of the award of the contract by the CSACS prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
