03.BID PRICE

05. VALIDITY OF QUOTATION

Quotation shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

06. EVALUATION OF QUOTATION

The CSACS shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- a) are properly signed; and
- b) conform to the terms and conditions and specifications.
- c) The quotations would be evaluated for all the items together.
- d) the vendor should have TIN/ Service tax registration number and the same should have been reflected on letter head

07. AWARD OF CONTRACT

The CSACS will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 6.1 Notwithstanding the above, the CSACS reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- 6.2 The bidder whose bid is accepted will be notified of the award of the contract by the CSACS prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

 Payment shall be made on quarterly basis after having satisfactory report from Store Officer, CSACS.

The damaged spare part(s) shall be replaced by new spare parts by the firm as its own cost and shall keep the parts readily available to reduce the downtime.

- **10.** All the Computers/Printers are in working conditions and vendor can check at any time on any working day between office hours.
- 11. You are requested to provide your offer latest by 2.00 P.M hrs. on 02/05/23 FOR CAMC OF COMPUTERS AND PRINTERS.
- 12. There should be one preventive maintenance service in a month and report of the same may get it signed from the concerned official of the society
- 13. Any breakdown call should be attended within 24 hours from the time of complaint.
- **14.** The cost of any part replaced in the computer is already included in the CAMC, thus no other charges may be charged from the Society
- **15.** If provided personally, suppliers are requested to drop quotation in quotation box lying at the reception.
- 16. Performance Security: Successful bidders will be required to furnish performance security equal to 10% the contract value in the form of Bank Guarantee or a Bank Draft in favor of "Chandigarh State AIDS Control Society- DBS". The Performance security shall be valid till the expiry of the period of the contract. The performance security deposit will be forfeited in case of any terms & conditions of the contract are infringed or the bidder fails to provide satisfactory service during one year and contract will be terminated.
